District Cost Share Applications

SWCD Board meeting July 10, 2024

Below is a summary of the cost share applications that will be presented at the meeting on Wednesday July 10, 2024. There are 11 project proposals that have been submitted. Application packets will be distributed next week as well as available during the board meeting. Current amount requested is \$54,205.00.

- 1. Kevin Conroy Haul Road project requesting \$3,000 worth of rock. Scott Susi provided the technical assistance as well as verified the road for eligibility.
- 2. Lance and Misty Stern -Rainwater harvesting, requesting \$7,500. I am recommending the board table this proposal until we are approved to move forward with the urban conservation program which will have separate funds to provide assistance for these types of projects. Landowner is willing to put this proposal on hold until then.
- 3. Tyler Neal Haul Road requesting \$3,000 for rock. This will be phase 3 of a multi-phased haul road system.
- 4. Rory Wilson Haul Road requesting \$3,000 for rock.
- 5. Bob Krein Solar Livestock Water requesting \$7,500. This project will replace a generator with a solar pump system and provide water to 2 pastures with the installation of a trough splitting the fence line, and pipeline that will send the over flow to a pond where the cattle currently water.
- 6. Lorne Richman Wildlife boundary fence requesting \$7,500. Work for this project has already started. SWCD Staff has provided technical assistance and suggested the landowner reach out to ODFW for help to keep elk and deer out of his hay fields.
- 7. Blaine Carver Irrigation pipeline requesting \$7,500. This project will replace an irrigation pipeline that connects an upper and lower pond. The current pipeline is failing and not large enough to keep up with the rate when filling the lower ponds. This project will increase the utilization of existing water and decrease the amount of water that needs to be diverted due to the current systems capacity.
- 8. Tyler Myers Haul Road requesting \$3,000. Scott provided Tyler with technical assistance and has verified the roads eligibility.
- 9. Brian Casady Livestock Solar Water requesting \$1,705. This project is to replace an ODFW livestock water trough. Portions of the system are functioning however ODFW does not provide any maintenance on these projects. Landowner is proposing to purchase a new submersible well solar pump, including all charger controller, panels and batteries and replace the existing water trough.
- 10. Lee Rahr Beaver Dam Analogs requesting \$7,500. This is a joint project with the landowner and the Executive Director of Oregon Beaver Cooperative as well as other landowners in the Dant area along Eagle Creek near the Deschutes River. They are proposing to construct 10 BDA's along Eagle Creek.
- 11. Dick Neal Haul Road requesting \$3,000. This is phase 2 of a multi-phased haul road system.
